Index factors are applied to the historical cost of tangible personal property (TPP) to estimate the current year's reproduction cost new (RCN). For example, the historical cost of a desk purchased in 2006 for \$250 is trended (factored) to the current year's RCN by selecting office equipment ("Office Equip") and the year 2006. Historical cost (\$250) is then multiplied by the factor (1.21) to estimate RCN (\$250 x 1.21 = \$303). If a specific class of TPP is not listed above, commercial average ("Comm. Avg.") factors are utilized.

Index factors are applied to the historical cost of tangible personal property (TPP) to estimate the current year's reproduction cost new (RCN).

For example, the historical cost of a tractor purchased new in 2000 for \$46,900, is trended (factored) to the current year's RCN by selecting farm grove ("Farm Grove") and the year 2000. Historical cost (\$46,900) is then multiplied by the factor (1.52) to estimate RCN (\$46,900 x 1.52 = \$71,288).

If a specific class of TPP is not listed above or on the next table, industrial average ("Indus. Averag.") factors are utilized.

For example, the historical cost of a metal lathe purchased in 1999 for \$32,000, is trended (factored) to the current year's RCN by selecting Metal Work ("Metal Work") and the year 1999. Historical cost (\$32,000) is then multiplied by the factor (1.48) to estimate RCN (\$32,000 x 1.48 = \$47,360).

If a specific class of TPP is not listed above or on previous sheet, industrial average ("Indus. Averag.") factors are utilized.
